## SECTION 6– ACCIDENTAL RELEASE MEASURES

### SPILL

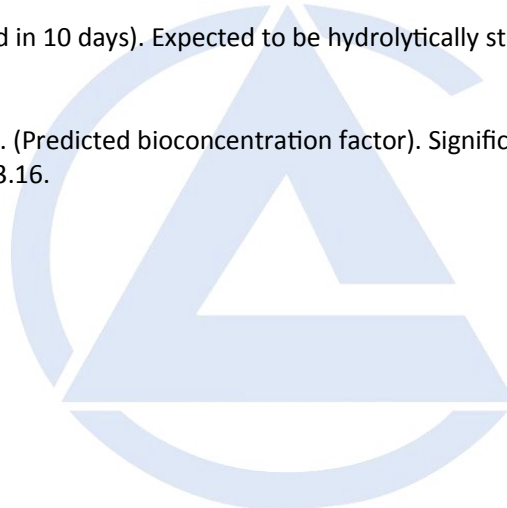
